WHEREAS , on April 14, 2014, the City, in anticipation of the formation of istrict library, agreed to end the general funding of library services if the district library assed on the August 5, 2014 ballot; and	
WHEREAS, the district library ballot proposal did pass by the voters of	the

Township and the City on August 5, 2014; and

WHEREAS, the resolution provided that as of the December 2014 tax levy, the Township would no longer impose a library millage to be paid by the City's general fund and the District Library Agreement provided for the termination of the City's payment obligations under the District Library Agreement as of December 31, 2014; and

WHEREAS, since December 31, 2014 the City has not billed from its general fund for library services but has billed separately from the millage fund established for the district library funding for library services; and

WHEREAS, it recently became known that some citizens expected that not only would the millage be reduced by half of the millage in December 2014, but the resolution contained in 2(b) "In future years, the City will reduce its general operating millage levy by 0.691 mills from the level that the City would otherwise have imposed,"; and

WHEREAS, it was not the intention of the City, beyond the December 2014 reduction in the general millage because of the passage of the district library millage, to burden the general fund by continuing the reduction of the former payment of library services of 0.691 mills; and

WHEREAS, library services have been established in a new stand alone millage rate, which has been approved by the voters of Independence Township and the City of the Village of Clarkston.

NOW THEREFORE, IT IS HEREBY RESOLVED by the City of the Village of Clarkston City Council as follows:

1. That the resolution adopted on April 14, 2014 be amended to strike 2(b) as the library millage is a separate stand alone millage for library services and is no longer part of an obligation for the general fund and it was not the Council's intention to subsidize by a reduction permanently of 0.691 mills for library services yearly that are otherwise separately authorized for the district library.
