## **Resolution - Administrative Staffing Proposal**

WHEREAS, the City Manager is proposing the following Administrative Staffing changes to address two recent retirements and the need to offer competitive compensation for purposes of employee retention:

- Move Jennifer Speagle from the current Admin/Enforcement position to City Clerk effective June 21st, increasing her annual salary from \$21,500 to \$26,500 (Jennifer's appointment to Clerk was approved June 10th)
- 2 Hire a part-time Administrative Assistant to replace Marcy Rotondo who retired January 7, 2019
- 3 Retain Greg Cote' as the City Treasurer with an adjusted work schedule to accommodate his other job
- 4 Increase the annual salary of City Manager Jonathan Smith from \$30,000 to \$34,000 (proposed by Councilman Reynolds)
- 5 Increase the hourly salary of DPW Supervisor Mike Speagle and DPW Worker Caleb Withrow by \$1
- 6 Eliminate the Enforcement position, as code enforcement and parking enforcement are now handled through other means
- 7 Change the City office hours (not DPW) to be closed on Fridays, versus the current 9:00 AM to Noon schedule

WHEREAS, the above listed changes are further detailed in the attached schedule, which also includes a salary comparison to the Municipal League 2018 Salary Study, and;

WHEREAS, the above listed changes, while increasing the employee's pay, will decrease the City's total salary budget from \$176K to \$172K, and;

WHEREAS, the above listed salary changes are reflected in the 2019-2020 FY Budget Proposal, and;

**NOW THEREFORE, BE IT RESOLVED** that the City of the Village of Clarkston hereby authorizes the City Manager and Treasurer to implement the above (and attached) changes with an effective date of the start of the 2019-2020 Budget (July 1, 2019).
