# Planning Commission Meeting August 3, 1998

Tim Birtsas (site plan review) brought in a revised site plan review. The following comments were recorded:

-lot coverage exceeds the limit (needs to meet standard or request a variance from ZBA

-reduce paved area (exclude parking in front of building)

-lighting???

-people getting from front unit to garage--conflict of vehicular/pedestrian traffic

Johnston, R.

-is the garage in the side yard/rear yard

#### Huttenlocher

-wait for Historic Commission before planning commission gives final approval

Ward

-discourage parking in front of building

#### Secatch

-25% building coverage (single family restrictions)

-have our engineer check for run off, etc.

-do owners have master deeds

-Birtsas to check with fire department

#### NBD Site plan review

Dave Harrison presented plans for the NBD building. It is to remain a bank so no use change. The following concerns were presented:

Ward moved, Kelley seconded the tentative approval of the site plan for the Clarkston State Bank, subject to the required variance for parking; approval of the ZBA regarding the signage; and subject to a revised site (an updated version) plan that includes the lower level and handicapped parking.
