D.P.W. Report

D.P.W. Supervisor Bob Pursley reported that FEMA would be reimbursing the City a sum of approximately \$2,000 for the snow emergency declared for January, 1999.

Pursley asked for a status report on the proposed improvements to the parking lot on Depot Road. Mayor Catallo stated that the project was still proposed, but funding has to be considered.

Pursley asked for a status report from the committee handling the building renovations. Kelley stated that the committee would be reporting to Council at the next regular meeting.

City Manager Report

Pappas reported that the City Engineer inquired as to whether or not they should contact Sunrise Assisted Living regarding engineering reviews for the Waldon/M-15 property. Council advised that no review would be required at this time; further contact with Sunrise Assisted Living will be considered if location in the City is pursued.

Sewer Use Rates

Pappas reported that the quarterly sewer rates charges by the Detroit Sewer and Water Department would be increasing in July. Council will act on a raise in sewer use rates after a Budget Committee review.
